

myFRONTMAN WEBSITE AND APP PRIVACY POLICY

MY FRONTMAN PTY LTD (herein referred to as “we”, “us” and “our”) is committed to protecting the privacy of our visitors and consumers. We know that keeping your personal information private is very important and we treat this as a priority.

Our Privacy Policy describes the types of information we gather on our website, www.myfrontman.com (“the Website”) and the myFRONTMAN app (“the App”), which is an app that offers a service that enables anyone the opportunity to access live broadcasts of video and audio of artist performances occurring around the world (“Content”). Our Privacy Policy also describes how we use this information. By using the Website or downloading the App, you agree to be bound by our Privacy Policy so please read this information carefully.

COLLECTION AND USE OF PERSONAL INFORMATION

When you use the Website or the App we collect personal information you give us which may include (but is not limited to) your user name, password email address, and the Content you purchase (“Personal Information”). We do not collect your credit card details. Your credit card details will be collected by either iTunes or Google Play. Please refer to the relevant privacy policy for more information.

When you browse the Website or App, we automatically receive your computer or mobile device’s internet protocol (IP) address in order to provide us with information that helps us learn about your browser and operating system. From an IP address it is possible to determine the general geographic location of that computer, but otherwise is anonymous. We do not keep a record of the IP addresses from which users access our website unless you have specifically provided us with information about yourself and in which case we also record your IP address for security purposes.

We use your Personal Information to complete transactions, respond to your questions and requests, deliver the Content you purchased, and may, with your permission, notify you of upcoming events and promotions, updates, or special offers that we think may interests you.

NOTIFICATIONS AND OPTING OUT

When you provide us with Personal Information we imply that you consent to our collecting it and using it for that specific reason only. If we ask for your Personal Information for a secondary reason, like notifying you of upcoming Content, voucher codes and special offers we think you may enjoy, we will either ask you directly for your express consent, or provide you with an opportunity to decline or opt-out.

You have the option to opt-out of receiving emails from us at anytime by clicking on the “unsubscribe” link in any email communications that we might send you. Alternatively, you may also contact us at support@myfrontman.com and confirm your email address and unsubscribe request.

DISCLOSURE OF PERSONAL INFORMATION

We may disclose information to service providers we have retained to perform services on our behalf. Where information is shared with third parties, they are obligated to observe the confidential nature of such information and are prohibited from using any or all of this information other than for the purpose for which it was provided.

We may also disclose your Personal Information to a law enforcement agency if we are required by law to do so or if you violate our Terms and Conditions of Use.

If we is acquired or merged with another company, your Personal Information may be transferred to the new owners.

Any Personal Information which is supplied and transmitted through the Website or App is protected via SSL Certification technology and HTTPS protocol in an attempt to stop your information being intercepted or read by unauthorised persons.

Unfortunately, the transmission of information via the Internet is not completely secure and we cannot guarantee the security of user information at any time. We accept no liability for breach of security or any unintended disclosure, loss or misuse of any information or data or for the actions of any third parties that may obtain any information or data.

You acknowledge and agree that you provide your Personal Information at your own risk.

Please ensure your anti-virus software, firewalls and other protection programs are kept up-to-date as we accept no liability for damage caused to your equipment arising from computer viruses, worms, spyware programs or otherwise.

BILLING INFORMATION

We have no access to your bank data, and do not store your bank or credit card information. Any credit or debit card information saved at the checkout is stored by either iTunes or Google Play, depending on which platform you download the App from.

We will not be responsible or liable for any damages or consequential losses (whether direct or indirect) suffered if your credit card is fraudulently used or is used in an unauthorised manner.
